1. Contact details	
Creditor.	The Co-operative Bank p.l.c.

2. Main features of the credit product	
The type of credit.	Overdraft.
The total amount of credit. This means the amount of credit to be provided under the agreement or the credit limit.	Your credit limit is the total amount we agree in advance that you can borrow at any time using your overdraft. We decide how much we will allow you to borrow based on your credit rating and other information about you. If we agree to offer you an overdraft facility we will tell you the credit limit we will allow when we send your overdraft agreement terms to confirm your overdraft. We can change your limit from time to time. Your overdraft agreement terms give more details about when we might do this.
The duration of the credit agreement.	This arranged overdraft has no fixed or minimum duration. We'll review your overdraft on an annual basis starting from the date we approve your application (we'll tell you this date when we open your account). We will normally notify you of any changes to be made one month before the end of each twelve month period.
Repayment of the credit.	You may be required to repay all amounts owed to us in full immediately on our written demand, at any time.

3. Costs of the credit	
The rates of interest which apply to the credit agreement.	You will not be charged any interest on your overdraft up to £200. You will be charged interest on any balance over £200 (but within your overdraft limit) at the rate of 1.24 % per month (15.9 % EAR [*]). If you exceed your overdraft limit without having agreed it with us in advance, interest will apply to any excess overdrawn balance over the agreed overdraft limit at a rate of 1.46 % per month (18.9 % EAR [*]). *Equivalent Annual Rate We can increase or decrease interest rates for one of the following reasons: (a) to take account of an actual, or reasonably expected, change in the interest rates we have to pay for example as a result of a change to the Bank of England Base Rate; (b) to reflect an actual, or reasonably expected, change in: (i) our underlying costs; (ii) law or regulation, codes of practice or industry guidance that applies to us, a ruling of a court, ombudsman or similar body or undertaking given to a regulator; or (iii) our way of doing business, including the introduction of new technology;

<p>The rates of interest which apply to the credit agreement (continued).</p>	<p>(c) if the change is for your benefit; or</p> <p>(d) to reflect any other actual or reasonably expected change that affects us if it is reasonable for us to pass the impact of the change on to you.</p> <p>Any change we make will be reasonably proportionate to the impact of the underlying change on us. We will not make changes to cover the same cost twice.</p> <p>We may also make changes to our interest rates without a particular reason (for example, increased competition may require us to change how we provide our services and what we charge for them) but, if we do this, we'll always explain how the change will affect you and you will be able to end this agreement without extra cost if you don't want to accept the change.</p> <p>If we decrease interest rates you pay:</p> <p>(a) the new rate will apply immediately; and</p> <p>(b) within the next 30 days we'll tell you about the change on our website, by branch notices, national press advertisements, statement messages or inserts or by writing to you (this can include email) or by any combination of these methods.</p> <p>We'll give you at least two months' notice before we make any other changes. The new terms will apply to your account automatically at the end of the notice period, but if you do not want to agree to the change, you can switch your account or close it without paying any extra charges or interest, at any time until the change takes effect. If you do not switch or close your account we'll assume you've accepted the change.</p>
<p>Costs.</p> <p>The conditions under which those costs may be changed.</p>	<p>When you have overdrawn or exceeded an overdraft limit without permission, a monthly charge of £10 will apply. Each subsequent day that your unarranged overdraft increases you will incur a daily charge of £10. We apply buffers, caps and waivers to our unarranged overdraft and service charges in certain circumstances.</p> <p>Monthly cap on unarranged overdraft charges</p> <p>The monthly cap on unarranged overdraft charges for your current account is £60.</p> <p>Each current account will set a monthly maximum charge for:</p> <p>a) going overdrawn when you have not arranged an overdraft; or</p> <p>b) going over/past your arranged overdraft limit (if you have one).</p> <p>This cap covers any:</p> <p>a) interest and fees for going over/past your arranged overdraft limit;</p> <p>b) fees for each payment your bank allows despite lack of funds; and</p> <p>c) fees for each payment your bank refuses due to lack of funds.</p> <p>This is a standard definition of the monthly cap on unarranged overdraft charges that all banks are required to use. The monthly cap refers to the charges applied in a charging period, not a calendar month. Please note that we do not charge fees for payments we refuse due to lack of funds.</p> <p>Overdraft Charges Cap</p> <p>We will not charge you more than £60 for any type of overdraft charge (including debit interest) in one charging period. This means that whatever type of overdraft you use (arranged, unarranged or both), the maximum you will pay per charging period will be £60.</p> <p>If you are using both an arranged and an unarranged overdraft, we will apply unarranged overdraft charges and interest first up to the £60 cap followed by arranged overdraft charges and interest. Once the £60 cap is reached, we will waive any further charges or interest for that charging period.</p> <p>Please refer to the relevant current account charges leaflet for further information on our overdraft services and charges.</p> <p>We can make changes to our overdraft charges in certain circumstances. If we do so, we'll give you at least two months' notice in advance (unless the change is to your advantage), and you'll be able to close your account if you don't accept the change.</p>
<p>Costs in the case of late payments.</p>	<p>There are no charges for late or missed payments.</p>

4. Other important legal aspects

Termination of the credit agreement.	<p>The overdraft will continue until it is terminated by us or you.</p> <p>You can terminate the agreement at any time by repaying all amounts owed to us.</p> <p>We can terminate the agreement at any time by giving you at least two months' notice in writing.</p> <p>We may end the agreement and terminate your overdraft immediately, without notice, if we reasonably decide that:</p> <p>(a) you are seriously or repeatedly in breach of the terms and conditions of the overdraft or the linked current account;</p> <p>(b) you or any other authorised signatory or joint account holder of the overdraft or the linked current account are made bankrupt or enter into an Individual Voluntary Arrangement after you open an account; or</p> <p>(c) you or any other authorised signatory or joint account holder of the overdraft or the linked current account:</p> <ul style="list-style-type: none">• has carried out or tried to carry out fraudulent or illegal activity on the overdraft, the linked current account or any other service we operate, or we have reason to think you or they may do so in the future;• has caused or may cause us to breach any law, regulation, code of practice or other duty which applies to us as a bank;• has behaved improperly towards us or anyone providing services to us (for example, if you have threatened, abused or harassed a member of staff);• has given false or materially incomplete information when applying to open the overdraft, the linked current account or to use any service, or at any time thereafter; or• has allowed a person who is not an authorised signatory to use the overdraft, the linked current account or any other service we provide. <p>On termination of the agreement, you are required to repay all amounts owed to us by your use of this overdraft immediately on our written demand. Any written demand will be sent by post to the address last notified to us and will be treated as having been received by you 48 hours after posting. We will normally give you warning that your arranged overdraft must be repaid or its limit reduced, but we may ask for repayment without notice.</p> <p>If you terminate the overdraft and interest is payable on all or part of the overdraft, you will need to pay all interest which has been incurred during the period before the agreement can be terminated.</p>
Consultation with a credit reference agency.	<p>If we reject any application by you for an overdraft on the basis of information obtained from a credit reference agency, when we inform you of that decision we will also inform you (without charge) that our decision is based on information obtained from a credit reference agency, and of the particulars of that agency.</p>
Additional information which is relevant if you applied for this overdraft online	<p>The Financial Conduct Authority is the supervisory authority for consumer credit.</p> <p>This agreement (and all our dealings with you before the agreement) is governed by the laws of England and Wales. Any dispute that arises regarding this agreement will be dealt with by any court in the United Kingdom, Isle of Man and Channel Islands that is able to hear the case.
